MINUTES OF COMMITTEE MEETING OF BUDDHIST COUNCIL OF QUEENSLAND

MEETING DATE: 17th September 2005

Jim passed a comment on the fact that, owing to not being able to form a quorum for the August Committee Meeting, the Minutes that were accepted were for July. Also, some committee members thought that the meeting today was to be at 1pm. When, in fact, it was at 10.30am. Jim also stated that as we all took on this obligation, we should do our utmost to attend each and every meeting we have.

BUSINESS ARISING FROM THE PREVIOUS MINUTES

There was no business arising from the previous Minutes.

CONFIRMATION OF MINUTES OF PREVIOUS MINUTES

CORRESPONDENCE

Firstly, Jim explained that any correspondence that is undertaken on behalf of the BCQ must be handed over to the Secretary for tabling at meetings. Chee Wong handed over some emails from Chung Tian Temple.

BUSINESS ON NOTICE

- 1. There was a group discussion on the upcoming Multicultural Festival. Basically, we talked about who would be available to help, what handouts we could have there and which groups were coming. It was explained that we could not sell anything and we could not accept donations.
- 2. Chee Wong is going to obtain a loan of Buddhist Flags from the Cambodian Temple. Jim has organized a banner for the BCQ, he is also willing to set the stall up and take it down after the festival but would appreciate any help that can be given.
- 3. It was proposed that the BCQ immediately pay the Public Liability cover being offered by the M/Cultural Festival Organizers, the cost being \$75.00 for the day.

MEMBERSHIP – Jim asked if all Committee Members groups are financial members of the BCQ? The committee for the BBV said they will decide at their next meeting, which is going to be held at a date to be decided in October. Jim stated that it is part of our policy that anyone who is on our committee must be part of a financial member of the BCQ. Jim has put on record that the committee members groups have until the end of the financial year (31.12.2005) to become financial.

As we represent all Buddhists and not just groups, we need to look at the structure of memberships in the near future and to discuss and decide about giving voting rights to Individual members. We need to frame up a new resolution at the next committee meeting, to put before a Special General Meeting and then submit it to the Office of Fair Trading.

It was pointed out that this is a personal issue and our agendas are all different. Jim read out what he had written on the bottom of the Agenda for this meeting. This stated that "Member's are reminded the committee can only function through the support of its member's. Full attendance is encouraged at this meeting." Also, Lynn O'Connor raised the same issue regarding Siri Fernando, he also has not been attending meetings. Kim Hollow suggested that we may need to choose another day for meetings.

The Holy Relics Exhibition was well represented by the BCQ. There was a donation of \$100.00 donated on behalf of the BCQ.

Woodford Folk Festival Namgyall Monks is now out of our hands. Tenzin Choegyal is now managing the tour.

Karuna has the Namgyal Monks coming three times. First is to consecrate the ground for the Stupa. Secondly, to consecrate all of the Precious Objects that will go into the Stupa. The third time is to Bless the Stupa and commemorate it. This will all take place from January to March 2006.

The Monks may also be doing a Sand Mandala at the Brisbane Conservatorium at Southbank in late January 2006.

Basically we are no longer needed or invited to take part in their tour.
